Greetings from MEA President Kasey Buckles

Dear MEA participants,

Greetings, and welcome to Cleveland for the 87th annual meetings of the Midwest Economic Association! Once again, we offer a high-quality conference with over 400 research presentations, including special sessions organized by the Association of Environmental and Resource Economists (AERE), the Committee for the Status of Women in the Economics Profession (CSWEP), and the Society of Labor Economists (SOLE) among many others.

Members from all over the United States and the world are traveling to this year's meeting to present their research. In addition to distinguished faculty and professionals in the field of economics and business administration, we have papers from many PhD students as well as 20 papers by undergraduates selected for presentation in five special undergraduate sessions.

We are honored to host **Governor Lisa D. Cook**, Board of Governors of the Federal Reserve System, who will deliver the 2023 C. Woody Thompson Guest Lecture. Dr. Cook received a BA in philosophy from Spelman College. As a Marshall Scholar, she received a second BA in philosophy, politics, and economics from Oxford University before earning her PhD in economics from the University of California, Berkeley. Her plenary lecture will be on Friday, March 31, at 5:45 pm. Governor Cook will be introduced by Cleveland Federal Reserve Bank President Loretta Mester.

I will deliver the Presidential Address at the second plenary session on Saturday, April 1, at 5:45 pm. In my lecture "Breakthroughs in Census Linking Using Genealogy Data: The Census Tree Project," I will describe the exciting progress that my collaborators and I are making toward linking people in the 1850-1950 U.S. Censuses, in a dataset that we call the "Census Tree." To demonstrate the potential of the dataset, I will share our new estimates of the intergenerational transmission of socioeconomic status for both women and men.

This year, the MEA is offering a special event "Advice for Job Seekers: Finding the Right Fit" organized by the **Committee for the Status of Women in the**

Economics Profession (CSWEP) on Friday, March 31, at 3:30 pm. The panelists will offer insight and advice that should be useful to “rookie” job seekers and more experienced economists alike. All are welcome to attend, irrespective of gender identity.

The Midwest Economics Association is deeply grateful to the primary sponsor institution for this year’s conference, the Federal Reserve Bank of Cleveland. We also thank Marquette University, The Ohio State University, and University of Illinois – Urbana-Champaign. The generous financial support of these organizations contributes to the MEA’s mission to promote the advancement of economic knowledge and the economics profession through this annual forum.
